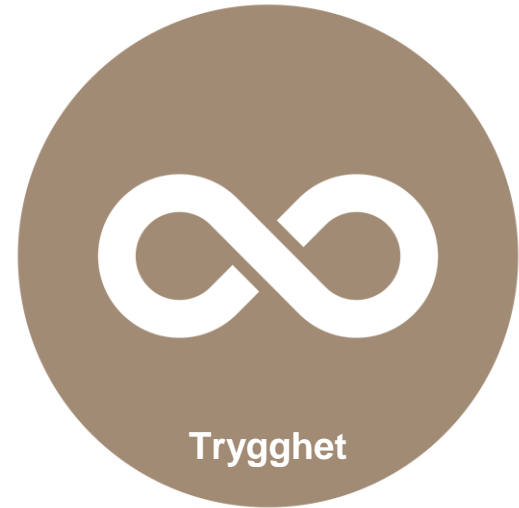

Monitor, analyse and influence rules & regulations, directives and other instruments

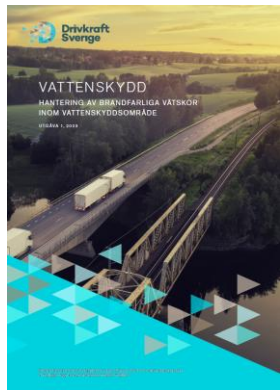

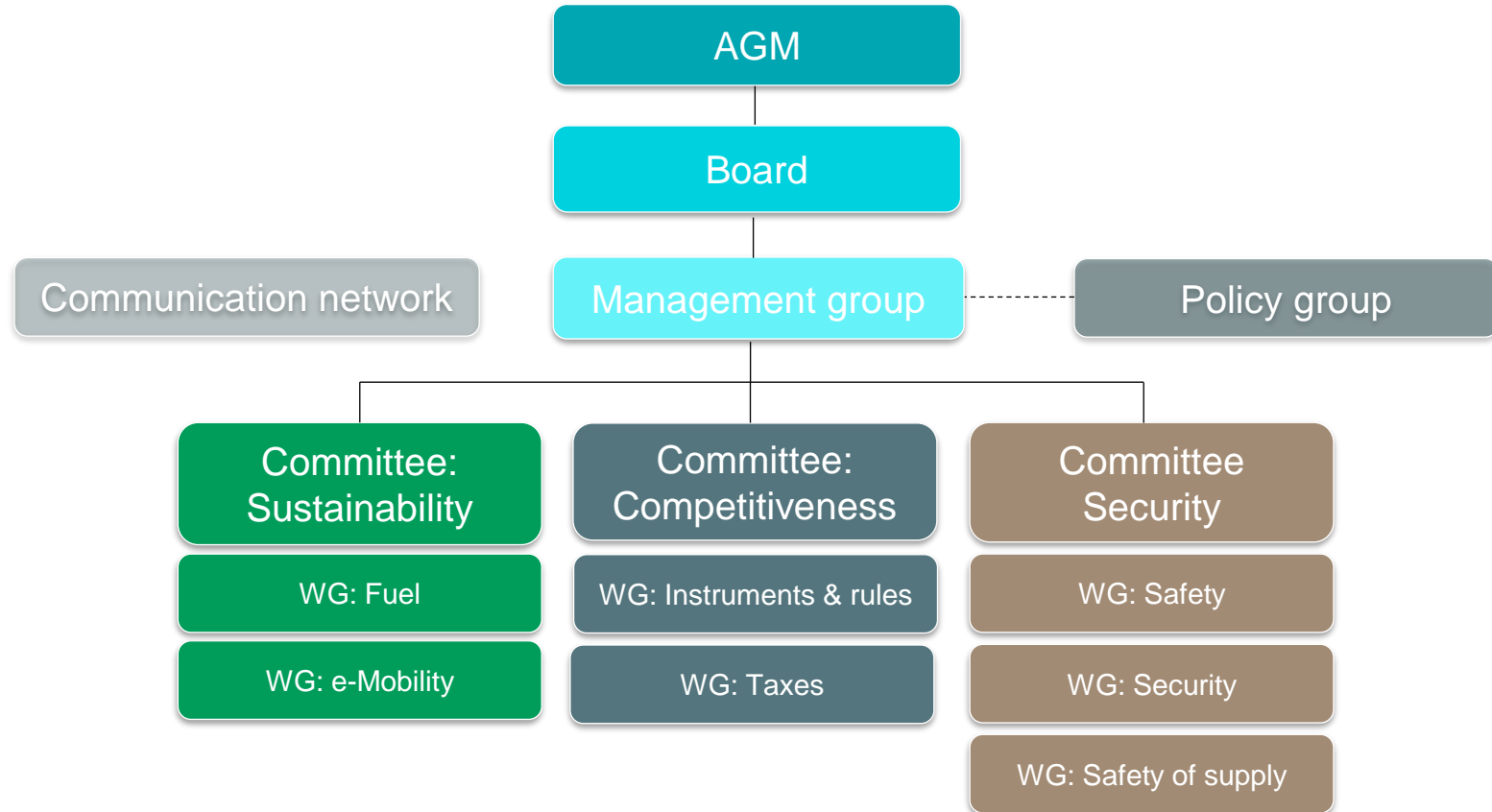

SPIMFAB

- SPIMFAB is a joint subsidiary within the fuel industry. The company runs a remediation program for gas stations that ceased operations between July 1, 1969, and December 31, 1994. On these properties, the company makes inventories, maps, and conducts soil investigations
- When necessary, SPIMFAB remediates and takes measures to manage the contaminated land



Släckmedelscentralen - SMC AB

- Släckmedelscentralen – SMC AB is a joint subsidiary within the fuel industry. The company was established in 1994 to meet current legislative requirements. The company aims to own and provide firefighting equipment and training to geographically selected rescue service organizations
- Businesses within the storage industry are offered the opportunity to sign agreements to supplement their preparedness in the event of a tank fire
